The Alberta Gerontological Nurses Association and the Canadian Gerontological Nursing Association are pleased to announce the 20th Biennial CGNA Conference to be held at The Westin Calgary, Calgary, Alberta, Canada. You are invited to submit an abstract for consideration as an oral, poster or workshop presentation.

Here are some suggestions for topic focus:

- Older Persons' Transitions
- Transitional Care
- Aging Trends and Policy
- Education
- Staff Development
- Mental Health (e.g., depression, delirium, dementia)
- Clinical Issues and Chronic Disease Management (e.g., continence, wound care, falls prevention, cardiac disease, stroke prevention, etc.)
- Gerontological Nursing Interventions - innovative approaches to self care management support, advance care planning, palliative approaches to care
- Integration of Primary and Community Care for Seniors

Abstracts that have been published elsewhere are not acceptable for presentation. Accepted abstracts will be published in the CGNA conference abstract book.

**Abstracts must be submitted through the online submission system per the instructions below. Abstracts will not be accepted by email.**

### Guidelines for submission

---

#### Abstract

The abstract must not exceed 250 words and ideally should relate to some element of the conference theme, if possible. Please indicate if your presentation will address an area of practice, research, education or leadership. Your abstract body should contain an introduction to the topic, the problem or topic being addressed, research or investigative methods (if applicable) outcomes/pertinent 'take home' messages.

## Criteria for evaluating abstracts

1. Relevance to conference theme
2. Innovation of work and contribution to nursing
3. Appropriateness of methods
4. Soundness of interpretations and discussion
5. Organization and clarity of writing.

## Who may submit an abstract

Nurses and those from other health disciplines in gerontological practice, education, administration, and research.

## Compensation for presentation

There is no compensation for presentations. **All presenters are expected to register for the conference and pay the conference fee.**

## PRESENTATION PREFERENCES

---

The aim of the conference is to foster dialogue and knowledge exchange around topics related to the conference theme. Participants are encouraged to consider one of the following formats for submission of their presentation. Please indicate your preferred presentation format during the abstract submission process: oral, poster or workshop. Please note, as oral presentation spaces are limited, abstracts submitted for oral presentation will also be considered for poster presentation.

### Oral Presentation

These presentations may include scholarly papers, completed research or innovation related projects. Sessions consist of 15-minute presentations, followed by a 5 minute question and answer period for each speaker (This time limit is subject to slight change, based on number of abstracts received and approved).

### Poster Presentation

Posters are displayed on a board approximately 4 feet high by 6-8 feet wide. A time for presentation will be scheduled in advance by the conference organizers with the expectation that the presenter will be present to answer questions and discuss with conference participants. Posters allow presenters to participate in extended discussion with interested attendees. The purpose of poster sessions is to allow an opportunity for participants to share ideas and insights and to interact around topics of interest.

### Workshop Presentation

This type of presentation allows for active participation by those in attendance. The format includes both presentation and some type of engagement of the attendees, such as small group discussion, over one hour or one and a half hours.

### To submit your abstract:

1. Enter your email address to create your account (you will need to do this only once).
2. Log in to the abstract submission system.
3. Follow the on-screen directions to complete your submission.
4. **Important information**
  - a. All abstract notifications will be sent to the e-mail address of the **abstract submitter. It is the responsibility of the abstract submitter to distribute the information to any presenting authors and/or co-authors.**
  - b. The abstract title and abstract will be printed in the program as entered. Please **do not use all caps** in the title or abstract.
  - c. The system will not accept abstracts longer than 250 words.
  - d. If you are an author on the abstract, you must include your **own name and affiliation** on step 2.
  - e. You may edit your abstract until the submission deadline through the abstract submission system
  - f. Please review the “Abstract Submission Do’s and Don’ts” at the end of this document.
